(b) Issue	Permission for allotment of additional space: M/s Systango Technologies Pvt. Ltd., a Unit in Crystal IT Park was issued LOA on 05/08/2014. The Unit has intimated that it has started commercial activities from 01/07/2015 and export for the financial year 2015-16 is ₹ 2.97 Crore. The unit has also stated that it is now planning to expand its operation and will add another 100 employees to the organization. However, the space allocated to the Unit at 3 rd floor of CIT is fully occupied and therefore it has requested that permission may be granted for allocation of 785.76 Sq. Meter space to the Unit in 4 th floor.
