ITEM NO - 2PROPOSALS RECEIVED FROM DEVELOPER

<u>I DEVELOPER PROFILE</u>

(b) Issue	Setting up of "Health Center" at TCS IT/ITES SEZ at Scheme No. 151 & 169B, Super Corridor, Village Tigariya Badshah and Bada Bangarda, Tehsil Hatod, Indore:- M/s TCS Ltd., Developer of IT/ITES SEZs at Super Corridor, Indore has submitted the captioned request for setting up of "Health Center" at their facility. The Developer has stated that to augment the extant Government and private health infrastructure, creation of TCS Covid-19 Health Centers in TCS facilities pan India is proposed. The objective of these Health Centers would be to provide medical cover to TCS associates and their family members tested positive for Covid-19 and are presently in the early stages of Covid-19 infection with mild symptoms or are asymptomatic. This will allow to lessen the burden on the existing health infrastructure on one hand, while providing the much needed support to TCSL employees and their families on the other.

	<p>The Developer has therefore proposed to set up a <u>temporary 20 bedded Health Centre</u> at the Gate house Complex No. 1, Recruitment Bay in their premises located at Scheme No. 151 and 169B, Super Corridor, Village Tigaria Badshah and Bada Bangarda, Tehsil Hatod, Indore. The Developer has submitted a layout of the proposed temporary Health Centre. The Developer has stated that they will not avail SEZ benefits on the goods utilized for the creation of the subject space. A list of goods for the proposed Health Centre has also been submitted.</p> <p>It is further informed that the proposed Health Centre will be managed by M/s Medi-assist Pvt. Ltd. who is in the business of offering health benefit administration services.</p> <p>Vide Instruction No. 50 dated 15.03.2010, the Department of Commerce has circulated a consolidated list of default authorized operations which can be undertaken by the Developer by default from the date of notification of the SEZ. As per the instruction, the DCs / UACs may allow Developer / approved Co-developers duty free goods and services for these default authorized operations from the date of notification of the SEZ. From the default list it may be seen that for all types of SEZs, as per point (A) S.No. 20, Medical centre and other such facilities is allowed as authorized activity which can be undertaken by the Developer by default from the date of Notification. Further, as per point (B)(1) of the list, for IT/ITES SEZs, in addition to the activities listed at (A), One First-Aid post or 10-bedded Clinic/Poly clinic/Pharmacy/Medical Center is allowed.</p> <p>In the instant request, the Developer has proposed to set up a temporary 20-bedded 'Health Center' without availing any duty benefits under the SEZ scheme.</p> <p>However, as per the provisions stated above, only 10-bedded Medical center is allowed for IT/ITES SEZs and there is no provision for 20-bedded Medical centre.</p> <p>The proposal is accordingly placed before the Approval Committee for consideration.</p>
