PROPOSAL NO. 1(i): M/s Yash Technologies Pvt. Ltd.

Request for approval of default list of Specified services required for authorized operations of the Developer, M/s Yash Technologies Pvt. Ltd. SEZ as per Instruction No. 79 and 94

of the DoC:-

M/s Yash Technologies Pvt. Ltd. was granted formal approval dated 04.07.2019 for setting up of sector specific IT/ITES SEZ on Plot No. 1 (part), scheme No. 166, Indore. The SEZ has been notified vide Notification dated 05.08.2019 over an area of 2.746 hectares which has been declared as processing area.

The Developer has submitted the captioned request for approval of default list of specified services in terms of Circular No. D.12/19/2013-SEZ dated 02.01.2018 read with Instruction No. 79 dated 19.11.2013 and 94 dated 08.05.2019 of the Department of Commerce, which requires that the list of specified services required for authorized operations be approved by the UAC of the SEZ for availing various exemptions. The developer has accordingly submitted a list of 67 specified services required for the authorized operations along with justification with reference to each of the services for its SEZ project on the afore-stated location. The list is placed before the Approval Committee for perusal.

	As per the DoC letter No. D.12/19/2013-SEZ dated 02.01.2018 all the UACs may permit the 66 services approved by the DoC, as the default authorized services in their respective zones. It is also clarified that consequent to implementation of GST Act, some State Govt. are not extending the benefits of IGST for default services and since SEZs are exempted from IGST on the default services, the BoA in its 80 th meeting held on 17.11.2017 has approved the reiteration of the default authorized services/operations, as approved earlier. The DoC had subsequently issued Instruction No. 94 dated 08.05.2019 vide which the list of default services was further expanded by adding one more service, making the list of default services as 67.

	M/s Yash Technologies Pvt. Ltd. was granted formal approval dated 04.07.2019 for setting up of sector specific IT/ITES SEZ on Plot No. 1 (part), scheme No. 166, Indore. The SEZ has been notified vide Notification dated 05.08.2019 over an area of 2.746 hectares which has been declared as processing area.
	The Developer has submitted a list of material to be procured by them for carrying out various construction activities in the SEZ as

per the default authorized operations, duly certified by the Chartered Engineer, for approval by the Approval Committee under the provisions of Rule 12 of SEZ Rules 2006. A Chartered Engineer certificate certifying the requirement of the requisite materials for construction of all types of building for IT/ITES units over an area admeasuring 19,405.01 sq. mtrs. having the total material value (indigenous and imported) as Rs. 88,40,37,381.11/has been enclosed. The list is placed before the Approval Committee for perusal.

Rule 12 of the SEZ Rules, 2006 stipulates that the developer may import or procure goods and services from the DTA without payment of duty, taxes and cess for the authorized operations, subject to the provisions contained in the sub rules (2) to (8). Rule 12 (2), further states that the developer shall make an application, after obtaining approval for the authorized operations under Rule 9 (in this case the activity construction of all types of buildings is covered in default authorized operations that can be undertaken from the date of Notification of the SEZ), to the Development Commissioner along with the list of goods and services, including machinery, equipments and construction materials required for the authorized operations, duly certified by a Chartered Engineer for approval by the Approval Committee.

The Deptt. of Commerce has issued Instruction No. 50 dated 15.03.2010 and Instruction No. 54 dated 30.04.2010 circulating therein, a consolidated list of default authorized operations, which can be undertaken by the Developer/Co-Developer by default from the date of Notification. According to the Instruction, UACs may allow Developer/approved Co-Developers duty free goods and services for these default authorized operations from the date of Notification of the SEZ. These authorized operations will, however, continue to be subject to the various guidelines issued from Govt. from time to time. UACs while approving goods and services for such default operations may look into the actual requirements of the SEZ for such operations.

M/s Yash Technologies Pvt. Ltd. has submitted the details of default authorized activities i.e construction of all types of buildings for IT/ITES units, for which the requisite material will be used. The activities proposed by the Developer are permitted at S. No. 22 (A) in the list of default authorized operations which can be undertaken by the Developer from the date of Notification provided under Instruction No. 50 dated 15.03.2010 read with Instruction No. 54 dated 30.04.2010.
