The meeting of the Approval Committee constituted by the Govt. of India vide notification dated 05.02.2013 was held via video conferencing at 3:45 p.m. on 31.08.2020 in the Office of the Development Commissioner, Indore SEZ, Indore. Dr. S.K. Bansal, Development Commissioner, Indore SEZ, chaired the meeting. Shri Puneet Kumar, Addl. Commissioner, Income Tax, Indore (representing the Commissioner, Income Tax, Indore), Shri Shakti Singh Gohil, Asstt. Commissioner, Customs, Indore (representing the Commissioner, Customs, Indore), Shri Chandra Kant M. Ram, Asstt. DGFT, Indore (representing the Addl. Director General of Foreign Trade, Bhopal), Shri Dwarkesh Saraf, General Manager, MPSEDC Ltd., Indore (representing Managing Director, Madhya Pradesh State Electronics Development Corporation Ltd., Bhopal) and Shri Sanjeev Agrawal, Vice President - Operations (Developer & Special Invitee) participated in the meeting. Shri Anil Arora, Chief General Manager, MPIDC (representing the Managing Director, MPIDC Ltd., Bhopal) participated in the meeting through teleconference.

2. Shri Puneet Arya, Specified Officer (Customs), Indore SEZ assisted the Committee in its deliberations. Shri Ravi Chhangani, ADC (Projects) presented the proposals before the Committee.

B. Proposal received from new units:-

- 1. M/s Impetus Infotech (India) Pvt. Ltd. (Unit-II) Request of M/s Impetus Infotech (India) Private Limited situated at Impetus Infotech (India) Pvt. Ltd. SEZ for change of name in LoA Approved. The Committee deliberated in detail on the contents of the Agenda. After deliberations, the Committee decided to approve the proposal for change of name in LoA from M/s Impetus Infotech (India) Private Limited to M/s Impetus Technologies India Private Limited duly noting that there is no change in the Board of Directors and shareholding pattern of the company and the unit has submitted an undertaking that pursuant to change of name of the company, the SEZ unit shall not opt out or exit out of the SEZ and continue to operate as going concern and that all liabilities of the unit will remain unchanged on such reorganization. The approval is subject to following conditions:
 - (i) Seamless continuity of the SEZ activities with unaltered responsibilities and obligations for the altered entity;
 - (ii) Fulfillment of all eligibility criteria applicable, including security clearances etc., by the altered entity and its constituents;
 - (iii) Applicability of and compliance with all Revenue/Company Affairs/SEBI etc. Act/Rules which regulate issues like capital gains, equity change, transfer, taxability etc.
 - (iv) Full financial details relating to change in equity/merger, de-merger, amalgamation or transfer in ownership etc. shall be furnished immediately to Member (IT), CBDT, Department of Revenue and to the jurisdictional authority.
 - (v) The Assessing Officer shall have the right to assess the taxability of the gain/loss arising out of the transfer of equity or merger, de-merger, amalgamation or transfer and ownership etc. as may be applicable and eligibility for deduction under relevant Section of the Income Tax Act, 1961.
 - (vi) The applicant shall comply with relevant State Government laws, including those relating to lease of land, as applicable.
