Accordingly, after deliberations, the Committee approved the proposal for setting up a new unit for Software Development and Consultancy / Information Technology / Information Technology Enabled Services in terms of the provisions of Rule 18 read with Rule 17 of SEZ Rules, 2006, in Infosys Ltd.
