The meeting of the Approval Committee constituted by the Govt. of India vide notification dated 26.07.2007 was held via video conferencing at 3:00 p.m. on 26.03.2021 in the Office of the Development Commissioner, Indore SEZ, Indore. Dr. S.K. Bansal, Development Commissioner, Indore SEZ, chaired the meeting. Shri Buddhiprakash, Asstt. Commissioner, Customs, Indore (representing the Commissioner, Customs, Indore), Shri Chandra Kant M. Ram, Asstt. DGFT, Indore (representing the Addl. Director General of Foreign Trade, Bhopal), Shri Dwarkesh Saraf, General Manager, MPSEDC Ltd., Indore (representing Managing Director, Madhya Pradesh State Electronics Development Corporation Ltd., Bhopal) participated in the meeting. Shri Anil Arora, Chief General Manager, MPIDC Ltd. (representing the Executive Director, MPIDC Ltd., Regional Office, Indore – Developer & Special Invitee) participated in the meeting through teleconference.

2. Shri V.K. Sharma, Specified Officer (Customs), Crystal IT Park SEZ assisted the Committee in its deliberations. Shri Ravi Chhangani, ADC (Projects) presented the proposals before the Committee.

The following proposals were placed before the Approval Committee:

Proposal wise decisions taken are as under: -

- A. Ratification of the minutes of the First Meeting It was informed that no reference suggesting amendment in the decisions of the Approval Committee Meeting held on 31.08.2020 was were ratified.
- B. Proposal received from/concerning existing unit(s):-
- 1. M/s Neno Systems Consulting Service Pvt. Ltd. Monitoring of APRs Monitoring of performance of the unit's (APR) for the period 2018-19 and 2019-20 in terms of Rule 54 of SEZ Rules, 2006 prior to grant of Exit permission to the unit The Committee deliberated in detail on the contents of the Agenda. The Committee was

informed that the unit is holding LoA dated 25.02.2016 for Computer Software Development which is valid up to 31.01.2022 and that the unit has submitted an application for de-bonding and exit from SEZ scheme under Rule 74 of SEZ Rules, 2006. The Committee noted that the unit has completed the requisite exit formalities and has obtained NOC from SEZ Customs after payment of applicable duties including No dues certificate and NOC from the Developer, MPIDC Ltd., Regional Office Indore regarding exit /vacation of premises. A gist prepared on the basis of data provided in the APRs of 2016-17 to 2019-20 along with a Chartered Accountant certificate submitted regarding FOB value of Exports, CIF value of Imported Capital Goods, CIF value of Imported RM/inputs, Other Foreign Exchange outgo and NFE achieved by the unit during 2016-17 to 2019-20 and during 2020-21 (April'2020 to December'2020) was circulated to the members of the Committee. The Committee noted that the unit has informed that foreign exchange amounting to Rs. 4.55 lacs is pending for realization from M/s Vedantus Solutions Pty Ltd., Australia for which the unit has filed a suit before Victorian Civil and Administrative Tribunal (VCAT), Australia along with a trivial amount of Rs. 0.04 lacs for trial services provided to a client in USA. The unit has further stated that they have achieved Positive NFE during their business years and if they are not able to realize the above amount, they will approach the RBI to write-off the unrealized amount as per FTP. Taking note of the above, after deliberations, the Committee while reviewing the APRs as per Rule 54 of SEZ Rules, 2006, noted that as per the Chartered Accountant certificate and CA certified APRs the unit has achieved 'Positive NFE' earnings during each of the period(s) 2018-19 and 2019-20 and also cumulatively during the period 2016-17 to 2019-20 and for 2020-21 (up to December'2020).
