PROPOSAL(S) RECEIVED FROM DEVELOPER

Review of progress of the Zone – Development activities undertaken by the Developer and status of utilization of land along with road map for development of the SEZ – In the Approval Committee meeting held on 23.02.2022 wherein while considering the proposal for enhancement of Unit II of M/s Infosys Ltd., the Approval Committee advised the representatives of M/s Infosys Ltd. to submit a detailed writ-up regarding the projected vis-à-vis actual exports effected, NFE achieved, employment generated, investment made etc. along with the road map for development of the entire area of SEZ, utilization of land etc. for review of the progress of the Zone by the Approval Committee.
