Minutes of the Approval Committee

Meeting No. 04 (2020- 21 series) held on 10.02.2021

The meeting of the Approval Committee constituted by the Govt. of India vide Notification dated 07.02.2007 was held via video conferencing at 3:00 p.m. on 10.02.2021 in the Office of the Development Commissioner, Indore SEZ, Indore. Dr. S.K. Bansal, Development Commissioner, Indore SEZ, chaired the meeting. Ms. Vinita Dubey, Dy. Commissioner, Income Tax, Indore (representing the Commissioner, Income Tax, Indore), Shri Buddhiprakash, Asstt. Commissioner, Customs, Indore (representing the Commissioner, Customs, Indore), Shri Chandra Kant M. Ram, Asstt. DGFT, Indore (representing the Addl. Director General of Foreign Trade, Bhopal) and Shri Anil Arora, Chief General Manager, MPIDC Ltd. (representing the Executive Director, MPIDC Ltd., Regional Office, Indore – Developer & Special Invitee) participated in the meeting.

2. Shri Puneet Arya, Specified Officer (Customs), Indore SEZ assisted the Committee in its deliberations. Shri Ravi Chhangani, ADC (Projects) presented the proposals before the Committee.

The following proposals were placed before the Approval Committee:

 2. M/s Shriji Polymers (India) Ltd., Plot No. M-9, SEZ Phase II, Indore SEZ, Sector 3, Pithampur, Distt. Dhar.

Proposal wise decisions taken are as under: -

- A. Ratification of the Minutes of the Third Meeting** – It was informed that no reference suggesting any amendment in the decisions of the Approval Committee Meeting held on 11.11.2020 was received and hence, the Minutes of the Third Meeting (2020-21 series) were ratified.
- B. Proposal received from/concerning existing unit(s):-**
- 1. M/s Kusum Healthcare Pvt. Ltd. - Request for inclusion of additional items of manufacture and enhancement of capacity of approved items in LoA dated 14.06.2010 - Approved.** The Committee deliberated in detail on the contents of the Agenda. The unit was represented by Shri Sanand Purohit, Manager who explained the proposal to the Committee. After deliberations, the Committee approved the request of the unit for inclusion of two additional items of manufacture in the LoA namely, “Granules Sachet/Pouches” having annual production capacity as 90 Million Nos. and “Pellet Sachet/Pouches” with annual production capacity as 12.50 Million Nos. along with enhancement in production capacity of two of the approved items of manufacture namely, Tablets from 310 Million Nos. to 600 Million Nos. and Capsules from 70 Million Nos. to 120 Million Nos. in terms of the provisions of Rule 19(2) of SEZ Rules, 2006.
 - 2. M/s Shriji Polymers (India) Ltd. - Proposal for expansion of its unit located at plot No. M-9, SEZ Phase II – Approved In-principle.** The Committee deliberated in detail on the contents of the Agenda. The unit was represented by Shri Anand Bangur, Director who informed the Committee that they are already manufacturing HDPE containers, CT and CR caps in there are existing facility located at plot No. M-9, SEZ Phase II, which they wish to expand and propose to invest Rs. 115.00 crores in the expansion project. The representative informed that a Letter of Intent (LoI) dated 15.12.2020 for the adjacent plot No. M-8, SEZ Phase II on which they propose the expansion has already been issued to them by MPIDC, RO, Indore, the Developer, and requisite payment for the same has also been made to the Developer. The Committee noted that the lease deed of the plot No. M-8 allotted by the Developer to M/s Sarks Metal Pvt. Ltd. has been cancelled. The representative of the Developer informed that the lease deed of the plot was cancelled vide their Order dated 02.12.2019 and that the appeal of the unit filed at various levels in the State Government has also been cancelled and the cancellation Order has been upheld. The representative informed that they have taken over the possession of plot No. M-8, SEZ Phase II and the same is now available for allotment. The Committee noted that as the lease deed of the land has been cancelled, the duty liabilities arising on M/s Sarks Metal Pvt. Ltd. are required to be ascertained to safeguard the revenue. The representative of the Developer informed that though they have taken over the possession, they are not aware of any material lying inside the premises. The Committee opined that before handing over the possession to the incoming unit, the Developer and the Specified Officer may take suitable action in a time bound manner as per procedure to complete requisite formalities such as drawing up of punchnama etc. for the material lying in the premises. The Specified Officer would also need to check the records at their end to



ascertain the duty liabilities. The Committee noted that the Developer has already issued a Letter of Intent for allotting plot No. M-8, SEZ Phase II in favour of M/s Shriji Polymers (India) Pvt. Ltd. and accordingly, after deliberations, decided to approve in-principle the proposal of M/s Shriji Polymers (India) Pvt. Ltd. for expansion of its existing facility by inclusion of three additional items of manufacture in the LoA namely, "HDPE Bottles" with the ITC(HS) Code 39233090 having annual production capacity as 17,52,00,000 Nos., "CT Cap" with the ITC(HS) Code 39235010 having annual production capacity as 10,56,00,000 Nos. and "CR Cap" having ITC(HS) Code 39235010 with annual production capacity as 10,56,00,000 Nos. in terms of the provisions of Rule 19(2) of SEZ Rules, 2006, and the subject land for the proposed expansion may be allotted by the Developer as per provisions.

3. **M/s Shree Flex Print Pvt. Ltd. - Request for allotment of additional land admeasuring approx. 8500-10000 sq. ft. for meeting the requirements of the present unit of M/s Shree Flex Print Pvt. Ltd. at SEZ Phase II operating under LoA dated 27.07.2013 - Approved.** The Committee deliberated in detail on the contents of the Agenda. The unit was represented by Shri Sumeet Bagarka, Director, who informed the Committee that they are facing space constraint in their existing facility at plot No. 24 to 27 & P-28, SEZ Phase II and have requested for additional land of approx. 8500-10000 sq. ft. adjacent to their current plots admeasuring for storage of raw material, finished goods and installation of some plant and machinery to meet the requirements of existing facility. The Committee noted that the Developer has submitted a confirmation for providing the additional land to the unit as per their requirement. Accordingly, after deliberations, the Committee approved the request of the unit for allotment of additional land adjacent to its existing facility as per the confirmation of the Developer.
- C. **Other Issues - Approval of building plans received from M/s Rusan Pharma Ltd. and M/s Shree Mahaveer Home Décor Pvt. Ltd. on the basis of technical inputs and approval accorded by MPIDC, RO, Indore, Developer, Indore SEZ, Pithampur - Approved.** The Committee deliberated in detail on the contents of the Agenda. After deliberations, the Committee approved the building plans of M/s Shree Mahaveer Home Decor Pvt. Ltd., Plot No. M-29, SEZ Phase II and M/s Rusan Pharma Ltd., Plot No. M-21, SEZ Phase II, Pithampur as per technical inputs & approval received from MPIDC, RO, Indore, Developer of Indore SEZ.
