### Minutes of the Approval Committee

#### **Meeting No. 03 (2019- 20 series) held on 13.11.2019**

The meeting of the Approval Committee constituted by the Govt. of India vide Notification dated 07.02.2007 was held at 11:30 a.m. on 13.11.2019 at the Office of the Development Commissioner, Indore SEZ, Indore. Dr. S.K. Bansal, Development Commissioner, Indore SEZ, chaired the meeting. Shri Sanjeev Kumar Srivastava, Superintendent (Technical), Customs, Indore (representing the Commissioner, Customs, Indore), Shri Chandra Kant M. Ram, Asstt. DGFT, Indore (representing the Joint Director General of Foreign Trade, Bhopal) and Shri Anil Arora, Chief General Manager, MPIDC (representing the Executive Director, MPIDC, Regional Office, Indore – Developer & Special Invitee) participated in the meeting. Shri Praveen Kumar, Addl. Commissioner, Income Tax, Indore (representing the Commissioner, Income Tax, Indore) participated through teleconference.

2. Shri Puneet Arya, Specified Officer (Customs), Indore SEZ assisted the Committee in its deliberations. Shri Ravi Chhangani, ADC (Projects) presented the proposals before the Committee.

  1. M/s Glenmark Pharmaceuticals Ltd., Plot No. 2, SEZ Phase II, Pharma Zone, Sector 3, Pithampur, Distt. Dhar.
  2. M/s Shree Tirupati Balajee FIBC Pvt. Ltd., AP-14, Apparel Park, SEZ Phase II, Sector 3, Pithampur, Distt. Dhar.

**Proposal wise decisions taken are as under: -**

- A. Ratification of the Minutes of the Second Meeting** – It was informed that no reference suggesting any amendment in the decisions of the Approval Committee Meeting held on 04.09.2019 was received and hence, the Minutes of the Second Meeting (2019-20 series) were ratified.





**B. Proposal received from/concerning existing unit(s):-**

- 1. M/s Glenmark Pharmaceuticals Ltd. - Amendment of approved item of manufacture and increase in annual capacity – Approved.** The Committee deliberated in detail on the contents of the Agenda. After deliberations, the Committee approved the request of the unit to amend the broad-banding permission granted for manufacturing of Semisolid Tacrolimus ointment 0.1% with annual capacity 12000 kg by deleting the said item in the LoA dated 01.07.2008 and adding the revised item of manufacture namely 'Semisolid products' along with enhancement in annual manufacturing capacity up to 20000 kg in terms of the provisions of Rule 19(2) of SEZ Rules, 2006.
  - 2. M/s Shree Tirupati Balajee FIBC Pvt. Ltd. - Enhancement of production capacity from 6000 MT per annum to 10000 MT per annum - Approved.** The Committee deliberated in detail on the contents of the Agenda. After deliberations, the Committee approved the request of the unit for enhancement in annual manufacturing capacity of the approved items of manufacture namely, FIBCs/Jumbo Bags from the existing capacity of 6000 MT per annum to 10000 MT per annum in terms of the provisions of Rule 19(2) of SEZ Rules, 2006.
  - 3. M/s Gepach International - Request for broad-banding of LoA by addition of new items of manufacture - LoA No. C-123/ISEZ/Proj./2017-18/339 dated 30.05.2017 – Approved.** The Committee deliberated in detail on the contents of the Agenda. After deliberations, the Committee approved the request of the unit for broad-banding of LoA dated 30.05.2017 by inclusion of additional items of manufacture in the LoA namely, Allopathic Tablets with annual capacity of 3000.00 lacs (in Nos.) and Allopathic Sachets with annual capacity of 50.00 lacs (in Nos.) in terms of the provisions of Rule 19(2) of SEZ Rules, 2006.
  - 4. M/s Gold Filaments Pvt. Ltd. – In the matter of renewal of LoA – Deferred.** The Committee deliberated in detail on the contents of the Agenda. The Committee noted that the requisite comments of the Income Tax Deptt. are yet to be received. The Committee further noted that since the LoA of the unit has already been renewed up to 11.09.2020, therefore, the operations of the unit are not being interrupted. Accordingly, the Committee deferred the agenda item.
