Minutes of the Approval Committee

Meeting No. 03 (2020- 21 series) held on 11.11.2020

The meeting of the Approval Committee constituted by the Govt. of India vide Notification dated 07.02.2007 was held via video conferencing at 3:00 p.m. on 11.11.2020 in the Office of the Development Commissioner, Indore SEZ, Indore. Dr. S.K. Bansal, Development Commissioner, Indore SEZ, chaired the meeting. Shri Amit Kumar Soni, Dy. Commissioner, Income Tax, Indore (representing the Commissioner, Income Tax, Indore), Shri Y.M. Rawat, Asstt. Commissioner, Customs, Indore (representing the Commissioner, Customs, Indore), Shri Chandra Kant M. Ram, Asstt. DGFT, Indore (representing the Addl. Director General of Foreign Trade, Bhopal) and Shri Anil Arora, Chief General Manager, MPIDC Ltd. (representing the Executive Director, MPIDC Ltd., Regional Office, Indore – Developer & Special Invitee) participated in the meeting.

2. Shri Puneet Arya, Specified Officer (Customs), Indore SEZ assisted the Committee in its deliberations. Shri Ravi Chhangani, ADC (Projects) presented the proposals before the Committee.

The following proposals were placed before the Approval Committee:

- B. Proposal received from/concerning existing unit(s):-**
 1. M/s SRF Ltd., Plot No. C-1 to 8, C-21 to 30, D-13 to 18, D-25 to 32 and 41, 41A, 42, 43 & 54, 55, 56 & 56A, Indore SEZ, Phase – I, Sector – 3, Pithampur, Distt. Dhar – (M.P.).
 2. M/s Jash Engineering Ltd., Plot No. M-11, SEZ Phase II, Indore SEZ, Sector – 3, Pithampur, Distt. Dhar (M.P.) - 454 774.
- C. Any other proposal, if received.**

Proposal wise decisions taken are as under: -

- A. Ratification of the Minutes of the Second Meeting** – It was informed that no reference suggesting any amendment in the decisions of the Approval Committee Meeting held on 31.08.2020 was received and hence, the Minutes of the Second Meeting (2020-21 series) were ratified.



B. Proposal received from/concerning existing unit(s):-

1. **M/s SRF Ltd. - Request for enhancement of annual production capacity of Polyester Film plant (Line-I and Line-II) from 64123 MT to 78000 MT - Approved.** The Committee deliberated in detail on the contents of the Agenda. The Committee was informed that the unit is holding LoA for authorized operations i.e. manufacturing of Polyester Film, Metalized Film, Holographic File, Polyester Resin etc. and has proposed to enhance the annual capacity of its Polyester film plant (Line-I and Line-II) through de-bottlenecking process. The unit was represented by Shri Manoj Jain, Sr. Vice President who explained the proposal to the Committee. It was informed that in view of the increasing demand of packaged food they have planned for enhancement of annual production capacity of Polyester film plant wherein the annual production capacity of Line-I is being enhanced from 28753 MT per annum to 38000 MT per annum and that of Line-II from 35370 MT per annum to 40000 MT per annum i.e. the total annual capacity of both the Lines of Polyester film plant is being enhanced from the earlier approved 64123 MT per annum to 78000 MT per annum. It was further informed that an additional investment of Rs. 25.00 crores is being incurred for up gradation of equipments of Line-I as part of efficiency improvement and the Line-II improvements will be carried out without any cost involvements. After deliberations, the Committee decided to approve the proposal of the unit for enhancement of the annual capacity of the Polyester Film plant from existing 64123 MT to 78000 MT in terms of the provisions of Rule 19(2) of SEZ Rules, 2006.
 2. **M/s Jash Engineering Ltd. - Request for broad-banding of LoA by addition of new item of manufacture and enhancement in annual production capacity of one of the approved item of manufacture - Approved.** The Committee deliberated in detail on the contents of the Agenda. The unit was represented by Shri Dharmendra Jain, CFO who explained the proposal to the Committee. After deliberations, the Committee approved the request of the unit for broad-banding of LoA dated 24.08.2017 by inclusion of three additional items of manufacture in the LoA namely, "Industrial Valves (Fabricated)" with the ITC(HS) Code 84818030 having annual production capacity as 5000 Nos., "Machined Fabricated Products" with the ITC(HS) Code 73089090 having annual production capacity as 500 Ton and "Disk Filter" having ITC(HS) Code 84798999 with annual production capacity as 100 Nos. along with enhancement in production capacity of one of the approved items of manufacture namely, Sluice Gates from 500 Nos. to 5000 Nos. in terms of the provisions of Rule 19(2) of SEZ Rules, 2006.
