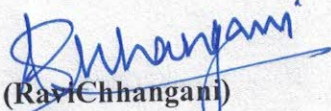

Minutes of the Approval Committee

Meeting No. 01 (2023- 24 series) held on 25.04.2023

The meeting of the Approval Committee constituted by the Govt. of India vide Notification dated 07.02.2007 was held at 3:00 p.m. on 25.04.2023 in the Office of the Development Commissioner, Indore SEZ, Pithampur. Shri Suvidh Shah, Development Commissioner, Indore SEZ, chaired the meeting. Shri Akash Agrawal, Dy. Commissioner, Income Tax (representing the Commissioner, Income Tax, Indore), Shri Harkesh Meena, Asstt. Commissioner, Customs, Indore (representing the Commissioner, Customs, Indore), Shri G.K. Mishra, Dy. DGFT, Indore (representing the Joint Director General of Foreign Trade, Bhopal) and Shri Anil Arora, Chief General Manager, MPIDC Ltd., Regional Office, Indore (representing the Managing Director, MPIDC Ltd., Bhopal) participated in the meeting.

2. Shri Santosh Kumar, Specified Officer (Customs), Indore SEZ assisted the Committee in its deliberations. Shri Ravi Chhangani, ADC (Projects) presented the proposal before the Committee.

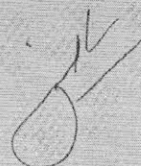
The following proposals were placed before the Approval Committee:

- C. Proposal received from/concerning existing unit(s):-
 1. M/s Printpoint Pharma Packaging Pvt. Ltd., Plot No. A-1, SEZ Phase II, Sector 3, Pithampur – 454 775, Distt. Dhar.
 2. M/s Ajanta Pharma Limited, Plot No. M-55-56-57, SEZ Phase II, Indore SEZ, Sector 3, Pithampur, Distt. Dhar (M.P.) – 454 775.
- D. Any other proposal, if received.

Proposal wise decisions taken are as under: -

- A. Ratification of the Minutes of the Tenth Meeting – It was informed that no reference suggesting any amendment in the decisions of the Approval Committee Meeting held on 02.03.2023 was received and hence, the Minutes of the Tenth Meeting (2022-23 series) were ratified.



B. Proposal received from new unit(s):-

M/s Rackbank Datacentres Pvt. Ltd. - Approved. The Committee deliberated in detail on the contents of the Agenda. The unit was represented by Sh. Narendra Sen, Director who explained the proposal to the Committee. The representative informed that the Company has proposed to set up a new service unit for Information Technology Enabled Services such as Other Business services i.e. Hosting and IT infrastructure provisioning services including storage, rack space etc. and Data Centre Managed services which shall include migration of customers on cloud, support in implementation of customers data centre requirements, management of data centre for customers in ensuring business continuity, to provide cloud services and/or to resale the cloud services of other cloud operators to the end customers, remote maintenance of server/ storage applications, data centre etc., along with Computer Software services. The representative stated that they would be bringing fiber connection and cooling at the desired location and the power would already be provided by the Developer. The representative added that they have revised their requirement of land in SEZ Phase II, Pithampur to 19500 sq. mtrs. The Committee noted that the unit has proposed an investment of Rs. 5.61 crores in the project with an employment of 30 persons along with an export earning of Rs. 11.75 crores in the five year period. The Committee further noted that MPIDC Ltd., Regional Office, Indore, Developer of the SEZ, has confirmed availability of land for setting up the proposed new unit in the SEZ, Pithampur. Accordingly, after deliberations, the Approval Committee approved the proposal of the service unit for Computer Software Services such as software integration services and allied services to end customers, ITES such as Other Business Services i.e. Hosting and IT Infrastructure Provisioning Services, Data Centre Managed Services etc. in terms of Rule 18 read with Rule 17 of SEZ Rules, 2006.

C. Proposal received from/concerning existing unit(s):-

- 1. M/s Printpoint Pharma Packaging Pvt. Ltd. - Enhancement of annual production capacity of two of the approved items of manufacture - Approved.** The Committee deliberated in detail on the contents of the Agenda. The Committee was informed that the unit is holding LoA dated 05.08.2014 for manufacturing of printed pamphlets, booklets, brochures, leaflets & printed books and other similar printed matter packed with pharma products along with folding cartons, boxes and cases of corrugated / non-corrugated paper and paperboard, Printed tags and labels, Registers, account books, note books, order books and similar articles etc. The unit is operational on plot No. A-1 in SEZ Phase-II, Indore SEZ, Pithampur w.e.f. 01.07.2015 and the LoA is presently valid up to 30.06.2025.

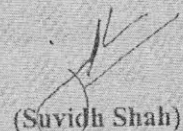
The unit was represented by Shri Guljar Presswala, Director who explained the proposal to the Committee. The representative informed that presently the unit is running in two shifts and in view of the good quantity of orders received from pharmaceutical units within the SEZ as well from their overseas customers, they have decided to optimally utilize the existing production capacity by running the third shift. He further informed that addition in plant & machinery amounting to Rs. 1.58 crores has already been done and starting of third shift will increase the

employment from the present 103 persons to 130 persons. Accordingly, after deliberations, the Committee approved the request of the unit to enhance the annual production capacity of the following approved items of manufacture i.e. 'Printed pamphlets, booklets, brochures, leaflets and other similar printed matter packed with pharma products' from the presently approved 550.00 Lakh Nos. to 850.00 Lakh Nos. and 'Printed books packed with pharma products' from the presently approved 15.00 Lakhs Nos. to 20.00 Lakhs Nos. in terms of the provisions of Rule 19(2) of SEZ Rules, 2006.

2. **M/s Ajanta Pharma Ltd. - Enhancement of annual production capacity of two of the approved items of manufacture - Approved.** The Committee deliberated in detail on the contents of the Agenda. The Committee was informed that the unit is holding LoA dated 02.12.2016 for the authorized operations i.e. Manufacturing of Tablets, Capsules, Powder and Liquid Orals. The unit is located on plot Nos. M-55-56-57, SEZ Phase II and commenced production w.e.f 27.02.2020. The LoA of the unit is valid up to 26.02.2025.

The unit was represented by Shri Sunny Joseph, Asstt. Manager who explained the proposal to the Committee. The representative informed that they have proposed to enhance the annual production capacity of two of their approved products i.e. Tablets and Capsules due to the reason that at present they are not able to utilize the present capacity in single shift production and now intend to increase the production by utilizing maximum available capacity in two production shifts. The representative stated that the present set up of their plant capacity is higher than the present output and some capacity is keeping idle, hence they want to utilize the maximum capacity. He further informed that they have already received consent to establish letter with increased production capacity for the aforesaid products from M.P. Pollution Control Board. The representative added that running the plant in two shifts will increase the employment from the present 340 persons to 400 persons. Accordingly, after deliberations, the Committee approved the request of the unit to enhance the annual production capacity of the following approved items of manufacture i.e. 'Tablets' from the presently approved 250000000 Nos. to 600000000 Nos. and 'Capsules' from the presently approved 45000000 Nos. to 144000000 Nos. in terms of the provisions of Rule 19(2) of SEZ Rules, 2006.
