#### **Meeting No. 02 (2020- 21 series) held on 31.08.2020**

The meeting of the Approval Committee constituted by the Govt. of India vide Notification dated 07.02.2007 was held via video conferencing at 3:00 p.m. on 31.08.2020 in the Office of the Development Commissioner, Indore SEZ, Indore. Dr. S.K. Bansal, Development Commissioner, Indore SEZ, chaired the meeting. Shri Puneet Kumar, Addl. Commissioner, Income Tax, Indore (representing the Commissioner, Income Tax, Indore), Shri Shakti Singh Gohil, Asstt. Commissioner, Customs, Indore (representing the Commissioner, Customs, Indore), Shri Chandra Kant M. Ram, Asstt. DGFT, Indore (representing the Addl. Director General of Foreign Trade, Bhopal) participated in the meeting. Shri Anil Arora, Chief General Manager, MPIDC Ltd. (representing the Executive Director, MPIDC Ltd., Regional Office, Indore – Developer & Special Invitee) participated in the meeting through teleconference.

2. Shri Puneet Arya, Specified Officer (Customs), Indore SEZ assisted the Committee in its deliberations. Shri Ravi Chhangani, ADC (Projects) presented the proposals before the Committee.




- A. **Ratification of the Minutes of the First Meeting** – It was informed that no reference suggesting any amendment in the decisions of the Approval Committee Meeting held on 29.06.2020 was received and hence, the Minutes of the First Meeting (2020-21 series) were ratified.





**B. Proposal received from/concerning existing unit(s):-**


- 1. M/s Shankar Soya Concepts - Request for re-classification of the products approved in the LoA and enhancement in capacity of the products thereof including deletion of one of the approved product – Approved.** The Committee deliberated in detail on the contents of the Agenda. After deliberations, the Committee approved the request of the unit for clubbing the following approved items of manufacture in their LoA dated 01.03.2011 viz. Soya Lecithin Powder/Liquid/Granules, Standard Mustard Lecithin, Soya Lecithin Oil and Sunflower Standard Lecithin Powder having common ITC(HS) Code as 29232010 under Single Classification i.e. “Lecitin and its Derivative Products” with the ITC(HS) Code 29232010 having enhanced annual production capacity as 25000 Tons and the item Soya Phosphotidyl Choline – 35 & 70 to be reclassified as “Phosphotidyl Choline” with ITC(HS) Code as 2923100 and enhanced annual production capacity as 5000 Tons, in terms of the provisions of Rule 19(2) of SEZ Rules, 2006. The other item of manufacture namely Crude Soya Oil was deleted from the LoA.
- 2. M/s Alkem Laboratories Ltd. - Request for broad-banding of LoA by addition of new item of manufacture - Approved.** The Committee deliberated in detail on the contents of the Agenda. After deliberations, the Committee approved the request of the unit for broad-banding of LoA dated 02.12.2016 by inclusion of additional item of manufacture in the LoA namely, “Liquid Orals” having ITC(HS) Code 30049099 with annual production capacity as 90000 units per annum in terms of the provisions of Rule 19(2) of SEZ Rules, 2006.
- 3. M/s Jash Engineering Ltd. - Request for broad-banding of LoA by addition of new item of manufacture and enhancement in annual production capacity of one of the approved item of manufacture - Approved.** The Committee deliberated in detail on the contents of the Agenda. After deliberations, the Committee approved the request of the unit for broad-banding of LoA dated 30.10.2007 by inclusion of two additional items of manufacture in the LoA namely, “Machined Fabricated Products (Parts of Sluice Gate)” with the ITC(HS) Code 73089090 having annual production capacity as 500 Tons and “Machined Castings Products” having ITC(HS) Code 73259999 with annual production capacity as 1000 Tons along with enhancement in production capacity of one of the approved items of manufacture namely Sluice Gates from 500 Nos. to 10000 Nos. in terms of the provisions of Rule 19(2) of SEZ Rules, 2006.
- 4. M/s Shree Tirupati Balajee FIBC Pvt. Ltd. - Request for enhancement of annual capacity of the quantity of approved items of trading - Approved.** The Committee deliberated in detail on the contents of the Agenda. The Committee noted that the unit is holding LoA dated 13.11.2009 for manufacturing and export of Jumbo Bags (FIBCs). The Committee further noted that the unit has been granted permission for Trading of plastic granules i.e. PP / LDPE / LLDPE and Master Batches granules. After deliberations, the Committee approved the request of the unit for enhancement of annual capacity of the approved items of trading i.e. PP granules from 1200 MT to 7800 MT and LDPE/LLDPE granules from 300 MT to 2000 MT in terms of the provisions of Rule 18 read with Rule 19(2) of SEZ Rules, 2006. The permission is





subject to the condition that the unit shall maintain separate records for trading and manufacturing activities.
