<u>I DEVELOPER PROFILE</u>

(b) Issue	Request of M/s Infosys Ltd., Developer of Infosys IT/ITES SEZ, Super Corridor, Indore for approval of list of material to be procured for carrying out default authorized operations in the processing area under Rule 12 read with Rule 10 of SEZ Rules, 2006 and Instruction No. 50 dated 15.03.2010 and No. 54 dated 30.04.2010 of DoC – Filing of list of material for approval of UAC:- M/s Infosys Ltd., Developer of Infosys IT/ITES SEZ, Super Corridor, Indore has submitted the captioned request for approval of list of material to be procured for carrying out default authorized operations in the processing area of the SEZ in terms of Rule 12 of SEZ Rules 2006 read with Instruction No. 50 dated 15.03.2010 and Instruction No. 54 dated 30.04.2010 of the Department of Commerce. The Developer has informed that the list of material submitted for approval of UAC pertains to the

material which is required by them to develop, maintain and upkeep the infrastructure of the SEZ.

The Developer has submitted a certificate of the Chartered Engineer, M/s D.S. Parihar & Associates, Indore vide which the Chartered Engineer has certified that the list of material annexed to the certificate is required to develop, maintain and upkeep the infrastructure i.e. SDB1, Tower-C, Utility Block, UGR Sump, STP Block, HSD yard, Security block and SEZ block (North Side) covering a space of 41653 sq. mtrs. with respect to the authorized operations namely, (i) Roads with Street lightning, Signals and Signage; (ii) Construction of all type of buildings in processing area; (iii) Telecom and other communications facilities including internet connectivity; (iv) Power (including power backup facilities) for captive use only; (v) Air conditioning of processing area; (vi) Access control and Monitoring system; (vii) Fire protection system with sprinklers, fire and smoke detectors; (viii) Cafeteria/Canteen for staff in processing area; (ix) Employee welfare facilities like Creche, Medical centre and other such facilities; and (x) Solid and liquid waste collection, treatment and disposal plants including pipelines and other necessary infrastructure for sewage and garbage disposal, Sewage treatment plants. As per the list, the material required for the purpose would be both imported as well procured from DTA. The estimated value of material to be imported and procured from DTA has been intimated as Rs. 8874.57 lacs.

Rule 10 of the SEZ Rules, 2006 provides that the Approval Committee may permit goods and services to carry on the operations authorized under Rule 9. Rule 12 of the SEZ Rules, 2006 stipulates that the Developer may import or procure goods and services from the DTA without payment of duty, taxes and cess for the authorized operations, subject to the provisions contained in the sub rules (2) to (8). Rule 12 (2), further states that the Developer shall make an application, after obtaining approval for the authorized operations under rule 9, to the Development Commissioner along with the list of goods and services, including machinery, equipments and construction materials required for the authorized operations, duly certified by a Chartered Engineer for approval by the Approval Committee. The approval under Rule 9 is to be taken from the BoA.

The Deptt. of Commerce has issued Instruction No. 50 dated 15.03.2010 circulating therein, a consolidated list of default authorized operations, which can be undertaken by the Developer/Co-Developer by default from the date of Notification. That is, for any activity not covered in the default list, a separate application under Rule 9 has to be made by the Developer to the

	<p>BoA. According to the Instruction, the DCs / UACs may allow Developer/approved Co-Developers duty free goods and services for these default authorized operations from the date of Notification of the SEZ. These authorized operations will, however, continue to be subject to the various guidelines issued from Govt. from time to time. UACs while approving goods and services for such default operations may look into the actual requirements of the SEZ for such operations. As per the consolidated list, the default authorized operations as proposed by the Developer are listed at Item-A - S.No. 1, 22,5,23, 21, 24, 7, 27, 20 & 3 in the Annexure to Instruction No. 50. Further, certain amendments have been made in Instruction No. 50 by the DoC vide Instruction No. 54 dated 30.04.2010 wherein S.No. 22(A) has been amended with the default authorized operations of construction of all types of building in the processing area as approved by the UAC.</p> <p>In view of the submissions of the Developer, a report regarding the actual requirement of the material by the Developer for the authorized operations mentioned in the list of materials was called from the Specified Officer of the SEZ. The Specified Officer has informed that the material/items mentioned in the list submitted by M/s Infosys Ltd., Developer of Infosys IT/ITES SEZ, Indore appears to be the actual requirement by the Developer for their authorized operations. Further, the list of material/items has been duly approved by the authorized Chartered Engineer/Architectural and Structural Consultant and therefore, the list of material/items may be approved.</p> <p>The proposal is accordingly placed before the Approval Committee for consideration.</p>
