The unit has informed that they are manufacturing and exporting different types of Nets including Sports Nets eg. Batting practice Net, Ski Net, Tennis Net, Volleyball Net, Soccer Net etc. The Sports Nets are manufactured with the same machines and same raw material with fabrication activity. The unit submits that, it has been granted approval for the item 'Nets' which is classified under ITC(HS) code 5608 and the item 'Sports Nets' are classified under ITC(HS) code 95069960. Accordingly, for better clarity in the approved items of manufacture and Customs purposes the unit has requested that the approved items namely, Nets may be reclassified and the capacity be modified as under:

The unit has stated that pursuant to re-classification of the approved item i.e. Nets into 'Sports Net' and 'Nets', there will be no revision in investment in plant & machinery and NFE earnings as the total annual production capacity will not change and remain the same.
