- The appointment will be on transfer on deputation basis. The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organization/ Department of the Central Government shall not exceed three years. The pay and allowances of the officer selected on deputation will be regulated in accordance with the instructions issued by Deptt. of Personnel & Training from time to time. The maximum age limit for appointment by deputation shall be not exceeding 56 years as on the closing date of the receipt of applications.
- Officers who volunteer for the post will not be permitted to withdraw their names later. The selected officer(s) can also be posted anywhere within the jurisdiction of DC, Indore SEZ (State of M.P) depending on the exigencies of work.
- Applications received after the last date/without through proper channel or unaccompanied by copies of CR Dossiers, vigilance & integrity clearance of the officer concerned will not be considered.

- The application may be submitted in the prescribed proforma (Annexure-I), which can be downloaded from the aforementioned website.
- At present the vacancy exists for Two deputation post of Preventive Officer (Customs). In case of certain unforeseen circumstances which may lead to premature repatriation of some existing officers to their parent department, including completion of deputation tenure of some officers, the number of vacancies may rise to 08 (eight).
- A Govt. Officer in a higher grade pay/ scale shall be ineligible for appointment on deputation to the post in lower grade pay/ scale in terms of Deptt. of Expenditure's O.M.No. 1/1/2008-LC dt. 26.03.2009 and DOPT O.M. No. 6/8/2009-Estt.(pay II) dt. 17.06.2010.
- As per DOPT's clarification vide ID Note No. 1268489/2017-Estt. (Pay-II) dated 24.10.2017, a person in higher pay scale/ grade pay on account of financial up-gradation under MACP/ Non-Functional Up-gradation (NFU) or Non-Functional Selection Grade would become eligible for deputation to a post in the lower pay scale/ grade pay of ex-cadre post equal to the pay scale/grade of his substantive post in his parent cadre. Further, in accordance with this Department's proposed guidelines on Deputation (Duty) Allowance, if the basic pay in the parent cadre has been upgraded on account of Non-Functional Up-gradation (NFU), MACP, NFSG etc., the upgraded basic pay under such up-gradations shall not be taken into account for the purpose of Deputation (Duty) Allowance. Accordingly, applicants who have got non-function up-gradation in the scale of Level 9 (9300-34800+GP 5400/-) in parent department may also apply for the post of Appraiser (Customs) and if selected, fixation of salary on deputation basis will be accorded as per above clarification.
